SECTION 1 - EXECUTIVE SUMMARY

1.1 General

Cosset Consultants was appointed by the National Universities Commission as Procurement auditors to review the procurement activities of the Africa Centre of Excellence for Future Energies and Electrochemical Systems (ACE-FUELS). It is one of the 17 Second Africa Higher Education Centres of Excellence for Development Impact (Ace-Impact) Projects.

1.2 Aim

The primary aim and objective of this Procurement Process Audit is to review the procurement, contracting and implementation processes and determine the extent to which laws guiding the procurement activities are complied with; and confirm their consistency with the ACE-Impact institutional guidelines and the World Bank general procurement principles. This audit also helps to identify non-compliances and deficiencies in the procurement activities and proffer appropriate corrective measures

1.3 Methodology and Review Procedure

1.3.1 Methodology

The methodology and approach adopted for this post review are in three phases: (i) Inception activities (ii) Field works/activities (iii) Preparation and presentation of audit reports.

Generally, these phases included the determination of scope of assignment and selection of contracts to review. The study and evaluation of the Project/Contract files and other documents. Interactive meetings with the procurement staff. Data collection and analysis; physical site inspections; and the preparation of inception, draft and final procurement audit reports.

Data collection at the ACEFUELS was carried out with the use of checklists. Appendix II.

1.3.2 Review Procedure

The audit procurement procedure used at ACEFUELS is based on the institutional guidelines and it also considered the levels of compliances with the guidelines and the achievement of the Bank's procurement principles.

However, the procurement process activities of ACE-FUELS are being implemented in consideration of section 15(1)a & b of the PPA 2007 Act as amended.

1.4 General Contract Packages

1. ACE-FUELS procured seventeen (17 contracts) in 2023. This is made up of fourteen (14) goods contract and three (3) works as shown in appendix 1 - Inventory of sampled and reviewed contracts.

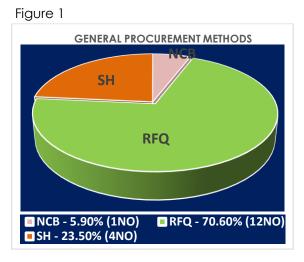
2. The appropriate procurement methods to use for every contract based on the threshold were also stated; alongside the methods used by the Centre. Appendix 1.

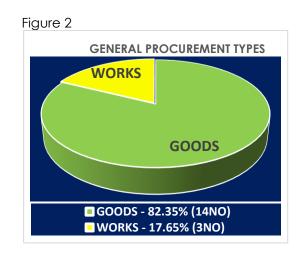
1.4.1 General Procurement Methods

The procurement methods used by the Centre were Request for Quotation (RFQ) with twelve (12) contracts at 70.60%. National Competitive Bidding (NCB) was used for one (1) contract representing 5.90%. Shopping (SH) was used for four (4) contracts representing 23.5% as shown on figure 1. Table 1 above shows the values of the procurement methods.



1.4.2 General Procurement Types

The procurement types were fourteen (14) goods at about 82.35% of procured contracts. Work has three (3) contracts at 17.65% as shown on figure 2. Table 1 above shows the value representation of the procurement types.



1.4.3 Sample Size

Random sampling was used to determine the audit sample size of 35.29% of the procured contracts. Six (6) contracts were selected for review. The selection considered the various procurement methods used as well as the procurement types. The sample is made up of five (5) goods and one (1) work at about 83% and 17% respectively. RFQ was used for five (5) of the samples while NCB was used for one (1). This is about 83% and 17% of the sample contracts respectively. Tables 3 & 4

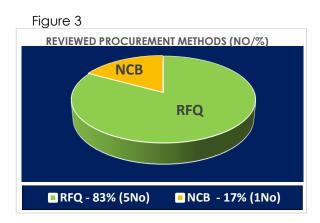

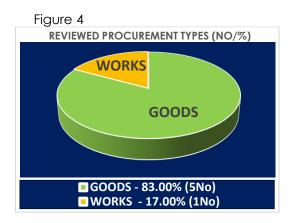
1.4.3.1 Sample Method

Five (5) sampled contracts representing about 83% were procured through RFQ while One (1), about 17% was NCB procurement. Figure 3



1.4.3.2 Sample Type

Five (5) sampled contracts representing about 83% were goods contacts while One (1), about 17% was work. Figure 4.



1.5 Findings

- The Centre used the University's procurement guideline and the Public Procurement Act (2007) as amended in the procurement activities.
- Standard Bidding Documents (SBD) were used for the procurement of the 18-Seater Mini Bus and the Contract for the maintenance of ACE-FUELS Hostel. They were not used for the other contracts.
- 3. The items procured were in the procurement plans.
- 4. The contract agreements were properly prepared as sighted.
- Advertisements were placed in two daily newspapers and in the Federal Tenders' Journal for the procurement of the of 18-Seater Mini Bus. The two (2) Newspapers ((i) Awareness Times of October 16, 2023 (ii) National Express of October 16, 2023) do not have good national spread and circulation.
- 6. The RFQ was used for most of the contracts. The Centre did not consider thresholds in determining the procurement methods.
- Mandatory Compliant Documents (TCC, ITF, PENCOM, NSITF, BPP-IRR were not seen to be used for most contracts procured through RFQs. The few where the mandatory documents were used were seen to be expired documents. (eg. Messers. Keliyke Associates Limited won the

contract for the Procurement of 30KVA Soundproof Diesel-Powered Generator but all the mandatory compliance documents were expired). Appendix vii. The same with the competitors Messrs. Synchro-Base Nig. Ltd submitted a TCC that expired on December 31, 2021, Messrs. Chiditech Works and Services Ltd submitted a TCC that expired on December 31, 2020.

- 8. Only the quotations of the successful bidders were presented while those of the unsuccessful were not sighted.
- 9. The ACSFUELS has qualified procurement staff whose primary assignments are with the CENTER. However, major contracts are still being handled by the central University procurement department.
- 10. Presentation of requested procurement documents were seamless.
- 11. Withholding Taxes (WHT) and Value Added Taxes (VAT) were deducted and remitted to the relevant tax authorities.
- 12. Contracts were presented and approved by the University Tenders' Board.

1.6 Exit Meeting

An exit meeting was held where communications on the preliminary findings were discussed with the Centre staff. This presented opportunities for the Centre to clarify issues raised, with explanations on the identified concerns. Issues of minor concerns were very few and these were resolved through explanations on the disputed areas. The exit meeting data table is as in the attached appendix iv.

1.7. Infractions

ACEFUELS was notified of the identified infractions. These were extracted from findings and from the general issues raised with the ACE-FUELS staff during the exit meeting. They are based on unsatisfactory explanations by the ACE-FUELS staff. Appendix iv. The following are where the explanations were not satisfactory.

1. The advertisements were poorly placed. Notwithstanding that there was placement in the Federal Tenders' Journal, the two newspapers do

not circulate widely in Nigeria. The National Express is published in Abuja while the Awareness Times, is published in Minna, Both in North Central Nigeria. Section 25(2) ii of the PPA 2007 as amended. By this, the primary procurement principles were circumvented. It is an offence as Clauses 58.4(b & e); 58.10(a & b of the PPA 2007 stated. This caused the poor response (2 submissions) to the advertisement with poor competition and transparency (clause 24 of the PPA). It also affected the expected level of Value-for-Money.

2. ACEFUELS does not consider the availability and the compliance to the mandatory requirements (TCC, ITF, PENCOM, NSITF, BPP-IRR) in selecting contractors to be invited to bid for Federal Government contracts. The practice is abuse of the provision of clause of clause 16(6)d of PPA 2007. Such was the case with the contract for the Procurement of 30KVA Soundproof Diesel-Powered Generator where all the mandatory compliance documents were expired. The same was the case for the Contract on Replacement and Installation of Micro Radio to Fiber Optics; the contract for the Procurement of Computers etc.

It would be noted that exemptions are not based on whether the company is a sole proprietor/business name, partnership, corporation nor on the value of the contract being bided for. Exemptions are evidential, backed up with proof from the various organizations/agencies and that is where registration for categorization and classification with the BPP comes in; with the issuance of the Interim Registration Report (IRR).

1.8 Procurement Process and Activities Assessment

The team considered the performance of the general procurement processes and activities to determine the level of exposure to perceived infractions and inconsistencies. The procurement activities were categorized into low, medium and high risks with percentages ranges of 0-39.99%, 40-59.99% and 60-100% respectively. Analysis of the specific contracts identified issues were carried out through the assessment matrix as shown with appendix iii, before the level of risks were finally aggregated and determined as stated. The performances of the procurement processes were put to test and categorized as "Poor" at a range of 0 - 49.99%, "Fair" at 50 - 69.99% and "Good" at 70 - 100%.

Overall, the **ACEFUELS** has a **"MEDIUM"** risk grading and a **"FAIR"** procurement performance score.

1.9. Rating and Classification

The audit review opinion is classified and rated as shown on table 5 below

1.10 Audit Opinion

ACE-FUELS, Federal University of Technology, Owerri is assessed to have earned a score of fifty-nine percent (59%). The procurement process at the Centre **NEEDS IMPROVEMENT**. The opinion is considerably based on the implementation of the processes and the results of the activities with regards to the levels of compliances to the institutional guidelines, the Public Procurement Act 2007 and the general procurement principles.

1.11 Recommendations

- It is important that the use of institution's procurement guideline be reconsidered if certain processes and criteria with weaknesses and limited compliances are to be improved upon.
- 2. Where required, advertisements for NCB contracts should always be placed in the Federal Tenders' Journal and in two national newspapers with wide circulation in both the North and the South of Nigeria.
- 3. Mandatory Compliant Documents (TCC, ITF, PENCOM, NSITF, BPP-IRR are the primary documents that a bidder should possess before being adjudged responsive to bid for Federal Government contracts. It should be outright disqualification for any bidder that do not have these current and complete compliant documents. This is the requirement of section 16(6)d of the PPA 2007as amended. Section 16(8)d of the same stated when compliance documents may not be required.

- 4. Agreement is a very essential contract document and the Centre should always endeavor to execute them for every contract awarded.
- 5. The Centre should observe the types of contracts of goods, works and services in the award of the contracts. The RFQ was observed to have been predominantly used, even where that was not the appropriate method. Thresholds should be taken into consideration in choosing the appropriate methods.
- 6. Continuous procurement training for staff of the Centre will improve the qualities of deliveries at every stage of the programme. This will enhance their understanding of procurement guidelines and the application of the principles.
- 13. The appropriate channels must always be used for the notification and solicitation for bids. Only two bidders responded to the advertisement for the 18-Seater Mini Bus probably because of the use of the Awareness Times and the National Express Newspapers.

SECTION 2 – INTRODUCTION

2.1 BACKGROUND

Due to the need to promote regional specialization amongst Universities in the West and Central Africa sub-region within disciplines that address particular common regional challenges, the Africa Center of Excellence (ACE) Project aims at strengthening the capacities of these Universities to enable them deliver high quality training and applied research.

1. AFRICA CENTRE OF EXCELLENCE (ACE 1) PROJECT

The Africa Centre of Excellence (ACE 1) project was instituted in 2013 by the Government of Nigerian, Ghana, Benin Republic, Togo, Burkina Faso, Cameroun and Senegal with support from the World Bank.

The Federal Government of Nigeria (FGN) entered into a credit agreement (Credit Number 5415-NG) after securing US\$70.0 million with the International Development Agency (IDA) of the World Bank (WB) to finance the ACEs project in 10 Nigerian Universities.

2. THE SECOND AFRICA HIGHER EDUCATION CENTRES OF EXCELLENCE FOR DEVELOPMENT IMPACT (ACE- IMPACT) PROJECT

The Second Africa Higher Education Centres of Excellence for Development Impact (ACE- Impact) Projects resulted from the successes achieved with the ACE 1. ACE-Impact project has 43 Centres in the Africa sub-region, with 17 of them being run by Nigeria Universities. ACE-Impact project (Credit Number 6510-NG) was designed to inject \$115 million into the Nigeria University System (NUS).

2.2. AFRICA CENTER OF EXCELLENCE IN FUTURE ENERGIES AND ELECTROCHEMICAL SYSTEMS (ACE-FUELS), FEDERAL UNIVERSITY OF TECHNOLOGY, OWERRI.

The Africa Center of Excellence in Future Energies and Electrochemical Systems (ACE-FUELS), Federal University of Technology, Owerri is one of

the 17 Nigerian Universities that are benefitting from the ACE-Impact project.

The (ACE-FUELS) stated its mission as "to operate practical and training geared towards transforming the nation's economy from consumeroriented to production-oriented, with a sound technology base; stating that it "focuses on four core areas of discipline namely; Clean and Future Energy, Electrochemical Systems, Nanotechnology and Corrosion Technology". "This is aimed at addressing the regional challenges of poor availability and access to energy"

2.3 NATIONAL UNIVERSITIES COMMISSION (NUC)

The **National Universities Commission (NUC)** of Nigeria is a parastatal under the Federal Ministry of Education (FME). It was established in 1962 as an advisory agency in the Cabinet Office and became a statutory body in 1974. NUC is a regulatory agency acting as a catalyst for positive change and innovation for the delivery of quality University education in Nigeria.

The **NUC** aims to: achieve a stable and crisis-free University System; upgrade and maintain physical facilities in the Nigerian University System for delivery of quality university education and match university graduate output with national manpower needs; work with Nigerian Universities to achieve full accreditation status for at least 80% of the academic programmes; foster partnership between the Nigerian University System and the private sector.

The National Coordination of the ACE projects is domiciled at the National Universities Commission (NUC). It is responsible for the National Project facilitation, training, and supervision in fiduciary aspects as well as national Monitoring and Evaluation (M&E) and minor Technical Assistance (TA) in Nigeria.

2.4 WORLD BANK PROCUREMENT GUIDELINE

The WB guideline has set rules guiding the procurement processes to be followed for procurement of good, works, consulting and non-consulting services being financed with loans from the WB. It covers the consideration of the WB core procurement principles in every contract.

Notwithstanding the established procurement guidelines, the FG/NUC and the WB have agreed to allow the ACEs Centres to use the various institutions guidelines for the implementation of the projects.

2.5 PUBLIC PROCUREMENT ACT (PPA) 2007

The Public Procurement Act 2007 as amended guides all procurement activities of the Ministries Departments and Agencies (MDAs) in Nigeria. The PPA is regulated by the Bureau of Public Procurement (BPP). One of BPP's functions is to regulate and ensure the reduction of infractions, weaknesses and non-compliances aimed at reducing corruption in public procurement. It also aims to ensure value for money, economy, transparency, competition, fairness, integrity and accountability in public procurement activities; improved professionalism and enhanced service delivery.

The PPA Act 2007 as amended provides the basic framework for the award and execution of contracts in Nigeria and promotes freedom of information that mandates all unclassified procurement records to be made available to appropriate public for inspection.

2.6 PROCUREMENT PROCESS AUDIT OF ACES

The purpose of the Procurement Audit of ACEs is to study, verify, interpret, and critically analyze all data, documents and Procurement statement collected/received and form true, fair and independent opinion on the Procurement Statements of the Procurement operation of ACE (Nigeria) for the period under review and to report findings to the National Universities Commission (NUC).

2.7 ENGAGEMENT OF COSSET CONSULTANTS

The NUC engaged Cosset Consultants to carry out post review of procurement activities of the 17 ACE-Impact Centres in fourteen (14) Nigeria Universities, including the ACE-FUELS, Federal University of Technology, Owerri, Imo State, Nigeria.

2.8 OBJECTIVES OF THE ACE-IMPACT PROJECT PROCUREMENT PROCESS AUDIT

This Procurement Audit is to identify and report on negligence in procurement management operations and decisions. It is also structured to bring to light all fraudulent acts, weaknesses, deficiencies and noncompliances that negatively affect procurement activities and recommend deterrents and corrective actions to ensure improved processes.

The Procurement audit gave objective assessments of the procedures specified in the Credit Agreement and determine the levels of compliances with institutional guidelines with respect to the considerations of the World Bank guiding principles.

2.9 METHODOLOGY

1. The methodology adopted for this assignment is generally concerned with investigations, inquiry, assertions, reasoning and research. The approach is objective, verifiable, and quantifiable. Interactions and interviews were held with officers of ACE-FUELS that were involved in the various stages of the procurement process/activities. The opinions and clarifications from the ACE-FUELS staff are considered and addressed in the report.

2. Contract data forms are used to collect the information that were analyzed. The contents of the form include information on general contracts, procurement and contracting, costs, time, contract administration, disbursement and deliverables. The documents made available to the consultant from which the data were collected include:

- (1) Procurement Plan.
- (2) Institution guideline.
- (3) Solicitation documents used for award.
- (4) Contract files.
- (5) Payment Vouchers.

3. Visits to selected project site was undertaken to determine the quality of materials and labour deployed to the work by the contractor. It also helps to determine the level of supervision from the ACE-FUELS procurement staff.

4. This data analyzed enabled the determination of the following critical success factors;

- (1) Compliance with the provisions of the World Bank Procurement Guideline.
- (2) Compliance with the provisions of the Public Procurement Act 2007 (examine the Management Control Framework in place to monitor procurement and contracting activities within ACE-FUELS PIU).
- (3) Compliance with the use of standard bidding documents (examine procurement documents and contracts files issued between the stipulated periods).
- (4) Compliance with the Code of Conduct for Public Officers involved in Procurement (review the processes undertaken by personnel of the ACE-FUELS Project who are directly involved in procurement and contracting activities).
- (5) Optimized commercial performance and value for money (review related procurement procedures, guidelines and processes and determine the level to which value for money was achieved).

5. Exit meeting was held with the procurement staff of the Centre. The observed key weaknesses and non-compliances were brought to their notice. The explanation given by the Centre staff are considered in the report.

6. The personnel interacted with at ACE-FUELS, FUTO during the field works were:

- (1) Centre Leader
 - (2) Procurement Officer
 - (3) Accountant

SECTION 3 – SCOPE AND REVIEW SAMPLES

3.1 AUDIT SCOPE

The procurement audit covers the review of all the procurement transactions, limited to the samples selected for audit, including prices reviews and compares of similar rates as at the time of award. Selected project site and inspection of procured goods, works and services are expected to be taken into consideration. The scope incudes determining the following:

- 1. Whether the procurement statements from the ACE-FUELS procurement unit conform to accepted procurement principles in accordance with the NUC/WB guidelines.
- 2. Whether they fairly represent the financial position of the procurement activities of ACE-FUELS.
- 3 Whether the result of operations for a given period are accurately represented.
- 4. Whether the procurement statements have been altered.

3.2 **REVIEW SAMPLE**

ACE-FUELS presented their procurement plan and a list of seventeen (17) procured contracts. Sixteen (16) were completed while one (1) was on-going.

Six (6) procurements were selected for review. The selection was 35.29% of the contracts procured. The review sample is about 77.60% of the value of all procured contracts.

The field work at the ACE-FUELS, was based on data sourced from available documents and information received from the Center's procurement unit.

The ongoing contract is at about 40% completion. This is about N7,841,915.00 completed. The actual value of completed contracts amounted to **N128,925,366.00**, which is the actual completed volume for the 2023 procurements.

This audit review was based on information extracted from the Center's Procurement documents that were made available to the Consultant by the ACE-FUELS staff. There were also interviews and interactions with key personnel

4. SECTION 4 – SPECIFIC CONTRACT/PROJECTS DETAILS

4.1. PROCUREMENT OF INO TOYOTA 18-SEATER MINI BUS

4.1.1 Introduction

This contract for the procurement of 1no.Toyota 18-Seater Mini Bus for the Africa Centre of Excellence in Future Energies and Electrochemical Systems (ACE-FUELS), Federal University of Technology, Owerri was procured using Selection. It was procured using National Competitive Bidding with advertisement placed in the Federal Tenders' Journal of October 16, 2023 to October 19, 2023. It was also published in the Awareness Times of October 16, 2023 and the National Express of October 16, 2023. Two bidders responded to the advertisement which closed on November 14, 2023. The bids were opened and examined by the Procurement Department of the University. Messrs Kojo Motor offered N57,803,468.00 on November 6, 2023 while Messrs. Africa Plus Ltd offered N67,359,500.00 on November 9, 2023. However, the Centre decided to go for a higher grade of the bus and requested offer from the lowest bidder who gave an offer of N66,329,788.00 on November 17, 2023. The procurement department made recommendation for award to be made to Messrs, Kojo Motors Limited, of No. 59, Razag Balogun Street Western Avenue, Surulere, Lagos. Notification of award of contract was communicated with Kojo Motors through an award letter dated November 20, 2023, in the contract sum of sixty-six million, three hundred and twenty-nine thousand, seven hundred and eighty-eight naira (N66,329,788.00). This is about USD81,113.54. The acceptance letter is dated November 20, 2023 while the contract agreement was signed on December 13, 2023. The Supplier offered to complete the contract within fourteen (14) days, but it was completed in ten (10) days.

4.1.2 Observations/ Findings

In line with the selection through NCB procedure, the following are the observations in the procurement process.

4.1.2.1 Procurement Planning

The procurement was in the signed 2023 Procurement Plan.

4.1.2.2 Advertisement

Advertisements were placed in the Federal Tenders' Journal of October 16, 2023 to October 19, 2023. It was also published in the Awareness Times of October 16, 2023 and the National Express of October 16, 2023.

4.1.2.3 Pre/Post Qualification

This is not within the threshold for prequalification.

4.1.2.4 Competition

The competition was poor as only two (2) bidders responded to the advertisement. The contributory factor for the low response could be because of the capacity of the newspapers that were used to publish the advertisement.

4.1.2.5 Bid Opening

Bids solicitation opened on October 16, 2023 and closed on November 14, 2023.

4.1.2.6 Bidding Documents

Standard Bidding Documents were used.

4.1.2.7 Evaluation of Bids/ Proposals

The bids Evaluation Report was not detailed but the lowest and best responsive bidder was recommended for the contract.

4.1.2.8 Awards of Contract

Notification of Award was communicated with Messrs. Kojo Motors on November 10, 2023 at the contract sum of N66,329,788.00. The acceptance letter was received on November 30, 2023. Contract Agreement was signed on December 13, 2023.

4.1.2.9 Contract Documents

The quotations, the Award letter, the Acceptance letters and the contract agreement constitute the contract documents.

4.1.2.10 Contract Implementation

Contract implementation was complimentary as the contract was completed within ten (10) days of award of contract.

4.1.2.11 Payments

The sum of N66,329,788.00 (inclusive of VAT, WHT and stamp duty) was paid to the contractor on December 18, 2023 with PV/2023/FUTO-1/000000683.

4.1.2.12 Physical Inspection

The Bus was seen at the ACEFUELS as captured and shown on appendix vi.

4.1.3 RECOMMENDATION

The Centre should always obey the rules and ensure that the appropriate channels of advertisement are adopted for wider reach, more competition and inclusiveness in the procurement process.

4.1.4 CONCLUSION

The ACEFUEL procurement staff should be exposed through trainings and workshops for improved procurement environment and the achievement of better VFM.

4.2. CONTRACT FOR THE MAINTENANCE OF ACE-FUELS HOSTEL

4.2.1 Introduction

This contract includes the maintenance and furnishing of the hostel block. RFQ were sent out to three (3) bidders on November 13, 2023. The bids were returned on November 27, 2023. The bid evaluation report was prepared on December 7, 2023 where recommendation was made by the procurement committee for award to be made in favour of the lowest bidder, Messrs. Honeydove Integrated Resources & Logistics Ltd. The University Tenders Board approved the recommendation and an award letter in the sum of N19.603,915.00 (about USD 23,973.23) was issued to the successful bidder as recommended through a letter dated December 8, 2023. The acceptance was made on December 18, 2023 with a signed contract agreement dated December 19, 2023. The completion date was January 26, 2024 (eight weeks). The work is ongoing as at the date of audit, and it is already about four (4) weeks behind schedule. No payment has been made to the contractor. A request for 100% payment was made on January 24, 2024 but the Centre leader approved 60% to be processed in favour of the contractor. The other quotations are, N20,034,882.50 submitted by Messrs Niaoson Resources Ltd and N22,210,575.00 submitted by Messrs Eagleseed International Ventures Ltd.

4.2.2 Observations/ Findings

The following observations were made regarding the procurement process of the contract.

4.2.2.1 Procurement Planning

The contract is in the Centre's 2023 procurement plan.

4.2.2.2 Advertisement

It was not advertised in the print media because of the threshold. However, it should have been placed on the Centre's website and notice board.

4.2.2.3 Pre/Post Qualification

The contract does not require pre-qualification. Bidders were invited to bid based on their credible past records with the University.

4.2.2.4 Competition

The bids were competitive and the prices are within prevailing market average.

4.2.2.5 Bid Opening

The bids were opened but the presence of the bidder's representative and independent observers could not be ascertained because bid opening register was not sighted.

4.2.2.6 Bidding Documents

Standard bidding documents were used for the procurement with Bill of Quantities and specifications issued to the bidders as well. Mandatory Compliance documents were not provided by the bidders. Only the TCC was solicited by the Centre.

4.2.2.7 Evaluation of Bids/ Proposals

The bids were evaluated, and approval was given by the appropriate University procurement committee before award letter was issued. The evaluation report was not detailed.

4.2.2.8 Award of Contract

The award was made to the lowest bidder. Notifications of award was made through the letters dated December 8, 20223.

4.2.2.9 Contract Documents

The Contract documents are well packaged with contract award letter, acceptance letter, signed contract agreement and the Bill of Quantities.

4.2.2.10 Procurement Duration

The procurement process duration was at 58 days. The actual works on site are ongoing.

4.2.2.11 Contract Implementation

The contract is being reasonably implemented. However, the Centre should have adequate and regular supervision of the contract to ensure that specifications are adhered to throughout the progress of the contract.

4.2.2.12 Payments

No payment of has been made as at the time of the audit. However, there was an approval by the Centre leader on January 19, 2024 for 60% payment in favour of the contractor.

4.2.2.13 Physical Inspection

Physical Inspection was carried out and the execution of the work seems to be slow.

4.2.3 Recommendation

(1) ACE-FUELS should always prepare detailed evaluation report.

(2) The work was too slow and the Centre should ensure that the completion period is not too elongated.

(3) Mandatory compliance documents are the primary consideration for award of Federal Government contracts and they must always be solicited from bidders.

4.2.4 Conclusion

The primary attribute of a good procurement is dependent on the level of compliances with the procurement principles. ACE-FUELS should always strive to achieve that.

4.3 PROCUREMENT OF 30KVA SOUND PROOF GENERATOR

4.3.1 Introduction

The Request for quotation for the procurement of the 30KVA sound Proof Generator was issues to three (3) bidders on April 25, 2023. All the three invited bidders responded and returned their quotations by the closing date on May 5, 2023. The quotations were evaluated and the lowest bidder was recommended for award. Through the notification letter dated May 24, 2023, the contract was awarded to Messrs. Keliyke Associates of 15 Ovim street (Prefab) Aladinma Owerri, Imo State at the contract sum of N9,236,162.50. the award was accepted by Messrs Keliyke Associates on June 12, 2023, while the contract agreement was executed and dated June 21, 2023. The contract was completed on June 22, 2023. That was fourteen (14) days earlier than the completion date of July 5, 2023. At completion, a net amount of N8,076,272.33 was paid to the contractor on July 7, 2023 through PV/2023/FUTO-1/00000331. The retention money was released on November 8, 2023.

4.3.2 Observations/ Findings

The review showed the following observation regarding the process.

4.3.2.1 Procurement Planning

This contract is in the ACEFUELS 2023 procurement plan.

4.3.2.2 Advertisement

It was not advertised, not even in the school notice boards and websites as it should. Quotations were extended to selected contractors that have been doing business with the University.

4.3.2.3 Pre/Post Qualification

Pre-Qualification exercise does not apply to this procurement.

4.3.2.4 Competition

There was considerable competition with the process based on the price competitiveness of the individual bidders' items.

4.3.2.5 Bid Opening

The bids were opened but the presence of bidders and independent observers could not be ascertained because bids return sheets were not sighted.

4.3.2.6 Bidding Documents

Standard bidding documents for minor procurement of goods were used for the procurement.

4.3.2.7 Evaluation of Bids/ Proposals

The bids were evaluated and analysed by the procurement committee. Approval was made by the University's Tenders Board before award letter was issued.

4.3.2.8 Award of Contract

The award was made to the best and lowest responsive bidder. Award letter with the contract price of N9,236,162.50 is dated May 24, 2023.

4.3.2.9 Contract Documents

The quotations, the award letter, acceptance letter and signed contract agreement constitute the contract documents.

4.3.2.10 Procurement Duration

The procurement duration was completed within 61 days. This is acceptable though it exceeded the period range by one (1) day.

4.3.2.11 Contract Implementation

The contract implementation was moderate considering the period within which the items were supplied to the Centre.

4.3.2.12 Payments

The net amount N8,076,272.33 was made on July 7, 2023 through PV/2023/FUTO-1/000000331. This was 15 days after submission of invoice by the contractor.

4.3.2.13 Physical Inspection

The audit team made physical inspection of the materials procured. Some are shown in the attached pictures. Appendix vii.

4.3.3 Recommendation

1. The records of bid opening process, including bid return sheets should always be used during bids openings and presented whenever required to authenticate the level of transparency of the process. PROCUREMENT AUDIT OF ACE-IMPACT PROJECT OF ACEFUELS - FUTO

2. Ensure that all bidders have the mandatory compliance documents before their bids are considered for evaluation. Expired mandatory compliant documents should also not be evaluated. There should be evidence of exemption where applicable.

4.3.4 Conclusion

1. Based on the audit process field work at the ACETFUELS, the Centre should be more circumspect while receiving and evaluating submissions from the bidders.

2. Compliance with the above recommendations would ensure smoother and more transparent procurement process.

4.4 PROCUREMENT OF COMPUTER

4.4.1 Introduction

This contract for the procurement of computers is in the 2023 procurement plan. Requests for Quotations were issued to three (3) bidders. On January 17, 2023. All the three invited bidders responded and returned their quotations by the closing date on January 31, 2023. The quotations were evaluated and the lowest bidder was recommended for award. Through the notification letter dated February 3, 2023, the contract was awarded to Messrs Naveton Nigeria Limited of 223 Ikorodu Road, Ilupeju, Lagos State at the contract sum of N6,791,688.75. The contract was completed on February 15, 2023. That was sixteen (16) days before the stated completion date of March 3, 2023 (4 weeks). Other bidders made submissions as follows, Messrs. Ifekesh Nig. Ltd. submitted the bid amount of N8,573,125.00, and Messrs. Tezmach Investment Ltd submitted N9,265,585.00.

4.4.2 Observations/ Findings

The review showed the following observation regarding the process.

4.4.2.1 Procurement Planning

This contract is in the ACEFUELS 2023 procurement plan.

4.4.2.2 Advertisement

It was not advertised in the school notice boards and websites as it should.

4.4.2.3 Pre/Post Qualification

Pre-Qualification exercise does not apply to this procurement.

4.4.2.4 Competition

There was considerable competition with the process.

4.4.2.5 Bid Opening

The bids were opened but the presence of bidders and independent observers could not be ascertained.

4.4.2.6 Bidding Documents

Standard bidding documents were used for the procurement.

4.4.2.7 Evaluation of Bids/ Proposals

The bids were evaluated and analysed by the procurement committee. Approval was made by the University's Tenders Board before award letter was issued.

4.4.2.8 Award of Contract

The award was made to the best and lowest responsive bidder, Messrs Naveton Nigeria Limited. Notification of award letter is dated February 3, 2023.

4.4.2.9 Contract Documents

The quotations, the award letter, acceptance letter and signed contract agreement constitute the contract documents. These were duly prepared and in accordance with the standard practice.

4.4.2.10 Procurement Duration

The procurement process duration was completed within 20 days.

4.4.2.11 Contract Implementation

The contract implementation was moderate considering the period within which the items were supplied to the Centre.

4.4.2.12 Payments

The payment voucher for the gross amount N6,791,688.75 was not sighted.

4.4.2.13 Physical Inspection

The team carried out physical inspection of the procured good and it was found to be in good working conditions Appendix vii.

4.4.3 Recommendation

1. Records of bid opening activities including bid return sheets and bid evaluation reports should always be prepared and kept for ease of retrieval for other purposes.

2. Ensure that all bidders have the current mandatory compliance documents. If they are exempted, evidence of the exemption must be attached.

4.4.4 Conclusion

The primary attribute of good procurement depends on the levels of compliance with rules and guidelines. ACEFUELS should always strive to achieve that.

4.5. PROCUREMENT AND INSTALLATION OF ELECTRICAL GENERATORS AT ACE-PUTOR

4.5.1 Introduction

This contract is in the 2023 procurement plan of the Centre and was procured through Request for Quotation (RFQ). Three (3) bidders were invited to submit quotations and all the three responded. The contract was awarded to Messrs Viamariae Tech. Ltd, with an award letter dated July 17, 2023. The contract amount was N3, 273,536.25.

4.5.2 Observations/ Findings

The review showed the following observation regarding the process;

4.5.2.1 Procurement Planning

This contract is in the ACE-FUELS 2023 procurement plan.

4.5.2.2 Advertisement

This does not require newspaper advertisement but should have been placed on the Centre website and notice board.

4.5.2.3 Pre/Post Qualification

Pre-Qualification exercise does not apply to this procurement.

4.5.2.4 Competition

There was considerable competition with the process.

4.5.2.5 Bid Opening

This nature of the bids opening could not be determined because of the value of the contract and the method of procurement. The bidders were not represented.

4.5.2.6 Bidding Documents

Standard bidding documents were not used, rather specifications were issued to the bidders.

4.5.2.7 Evaluation of Bids/ Proposals

The bids were evaluated by the procurement committee. Approval was made by the University's approval authority.

4.5.2.8 Award of Contract

The award was made to the best and lowest responsive bidder. Notification of award letter is dated July 17, 2023.

4.5.2.9 Contract Documents

The quotations, the award later, acceptance letter and signed contract agreement constitute the contract documents.

4.5.2.10 Procurement Duration

The procurement duration was completed within 84 days. This is long and it exceeded the time allowable for RFQ.

4.5.2.11 Contract Implementation

The contract implementation was good.

4.5.2.12 Payments

- N2, 698,764.19 net was paid on October 3, 2023 with PV/2023/FUTO-1/000000527.
- N152,257.50 WHT was deducted with PV/2023/FUTO-1/000000528 of October 3, 2023.
- N228,389.25 for VAT was deducted through PV/2023/FUTO-1/000000529 on October 3, 2023.
- N30,451.50 being for stamp duty was deducted on October 3, 2023. With PV/2023/FUTO-1/000000530.

4.5.2.13 Physical Inspection

The audit team carried out physical inspection of some of the materials procured.

4.5.3 Recommendation

Based on the audit process field work at the ACETEL, the Centre should be more circumspect while receiving and evaluating submissions from the bidders.

4.5.4 Conclusion

The primary attribute of good procurement is dependent on compliances with the procurement guiding principles. ACE-FUELS should always strive to achieve that.

4.6. PROCUREMENT OF LABORATORY EQUIPMENT (BALL MILL & ACCESSORIES)

4.6.1 Introduction

This contract is in the 2023 procurement plan of the Centre and was procured through Request for Quotation (RFQ). The invitation was issued on September 25, 2023 to three (3) bidders. and they responded positively and returned them on October 9, 2023. The contract was awarded to Messrs. Naveton Nigeria Limited of 223, Ikorodu Road, Ilupeju, Somolu, Lagos state, with an award letter dated October 16, 2023. The contract award amount was N3, 982,698.79.

4.6.2 Observations/ Findings

The review showed the following observation regarding the process;

4.6.2.1 Procurement Planning

This contract is in the ACE-FUELS 2023 procurement plan.

4.6.2.2 Advertisement

No advertisement was made.

4.6.2.3 Pre/Post Qualification

Pre-Qualification exercise does not apply to this procurement.

4.6.2.4 Competition

The bids were competitive and the prices are within the market averages.

4.6.2.5 Bid Opening

The bids were opened in the absence of the bidders.

4.6.2.6 Bidding Documents

Standard bidding documents were not used for the procurement, but schedules and specifications with similar contents were issued to the bidders.

4.6.2.7 Evaluation of Bids/ Proposals

The bids were evaluated as received by the procurement officer. Approval was made by the appropriate approval authority before award letter was issued.

4.6.2.8 Award of Contract

The award was made to the best and lowest responsive bidder. Notification of award letter is dated July 17, 2023.

4.6.2.9 Contract Documents

The contract award letter, the acceptance letter, the quotation and the contract agreement made up the contract document.

4.6.2.10 Procurement Duration

The procurement duration was completed within 20 days.

4.6.2.11 Contract Implementation

The contract implementation was good considering that there was no variation and the items were delivered within reasonable time.

4.6.2.12 Payments

- N3, 263,821.65 was paid using PV/2023/FUTO-1/000000621 of November 23, 2023.
- N184,199.82 was WHT paid with PV/2023/FUTO-1/000000622 of November 23, 2023.
- 3. N276,299.73 was for for VAT paid on November 23, 2023 with PV/2023/FUTO-1/00000623.
- 4. N36,839.96 was for STAMP DUTY paid with PV/2023/FUTO-1/00000624 of November 23, 2023.

4.6.2.13 Physical Inspection

The audit team carried out physical inspection and the pictures of the materials procured was captured as attached appendix vii.

4.6.3 Recommendation

ACEFUELS should ensure that the necessary compliant documents are sighted be evolution of bids. Where they were exempted, such exemption should be sighted and confirmed.

4.6.4 Conclusion

The primary attribute of good procurement is dependent on compliances with the procurement guiding principles. ACE-CUEL should always strive to achieve that.

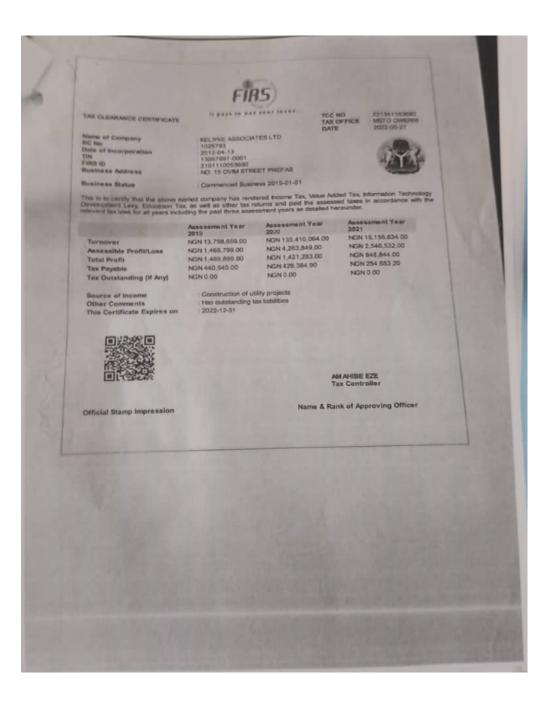

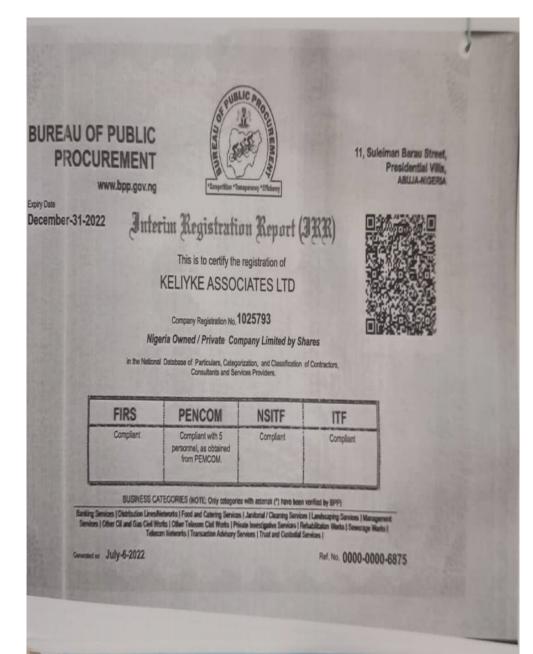

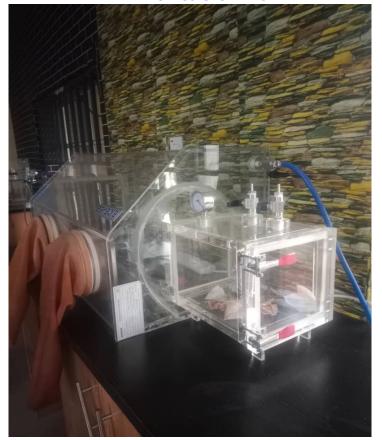
